Living and working conditions in Europe and in Germany are changing fundamentally. As a consequence of the crisis in Europe, an increasing digitalization of living and working environments, and new and precarious types of employment, the effects of this significant process of transformation have become clearly visible and tangible. Rights are curtailed, undermined, or not enshrined in law, for example in the context of modern information and communication technologies.

The scope of collective agreements and co-determination as well as the number of regular employments continue to decline. Asserting statutory rights has become more and more difficult for individuals because of changed labor relations. However, it is important for the cohesion of a democratic society and a general requirement for any economy in a globalized world that the needs of citizens and workers are voiced and met. Pertinent solutions will be discussed at the Legal Policy Congress.

The Congress will focus on key issues concerning the future of Europe, the implementation of basic rights, and the impetus needed for social legal policies. Legal provisions in the fields of collective bargaining autonomy, the right to industrial action, co-determination, the right of assembly, privacy, the freedom of movement, improved remuneration and better working conditions as well as questions concerning social minimum standards and effective legal implementation will be discussed. These elements of a new structure in living and working environments are particularly important in times of change.

Social legal policies have to include proposals that make adjustments possible and at the same time focus on unchangeable basic values and rights as well as secure social benefits in a social and democratic state based on the rule of law. The Congress, to which you are most cordially invited, is intended to contribute ideas. We look forward to your participation and our exchange of opinions!
